*I am the parent/legal guardian of Participant, a minor, named herein. I acknowledge and understand the risk inherent in recreational activities and that such activities entail risk of physical injury to his/her person and property. Notwithstanding such risks, I do hereby voluntarily agree to permit Participant to participate in the Event described herein.*

*For and in consideration of permitting Participant to participate in the Event:*

*o I hereby voluntarily release, discharge and waive any and all claims, actions or causes of action against the City of Barstow, its officers, officials, employees, agents and volunteers for personal injury, property damage or death occurring to Participant which may arise out of Participant's participation in the Event, and any activities incidental thereto, for him/herself and for his/her heirs executors, administrators and assigns. This release includes but is not limited to all liability for death, personal injury and property damage resulting from the active or passive negligence of the City of Barstow, its officers, officials, employees, agents and volunteers or any defective or hazardous condition of any property or equipment owned, operated or maintained by the City of Barstow.*

*o I voluntarily agree to assume full and complete responsibility for any personal injury and/or property damage or death that Participant may sustain or cause to be sustained by any other person in connection with Participant's participation in Event. I agree not to prosecute or present any claim for personal injury, property damage or death resulting from Event against the City of Barstow, its officers, officials, employees, agents and volunteers.*

*o I further acknowledge and understand that the City of Barstow, its officers, officials, employees, agents and volunteers are not responsible for Participant's personal injury, property damage or death resulting from Participant's participation in "hazardous recreational activity" (Government Code Section 831.7). I assume full and complete responsibility for any personal injury and/or property damage or death that Participant may sustain or cause to be sustained by any person during his/her participation in "hazardous recreational activity".*

*o I hereby release, indemnify and hold harmless the City of Barstow, its officers, officials, employees, agents and volunteers from any and all liability, including but not limited to bodily injury, property damage or death brought by any person arising from or related to Participant's participation in Event to the fullest extent permitted by law.*

*I understand that the City of Barstow does not provide any health insurance for injuries to Participant that may arise from participation in Event, and that I will be fully responsible for providing such insurance coverage.*

*I hereby authorize and give my consent for the necessary medical care to be given in an emergency situation to the Participant while participating in Event when neither the emergency contact on file with the City of Barstow nor a designated family physician can be contacted. I agree that it is my sole responsibility to ensure that the address and emergency contact information is accurate at all times.*

*I agree to be responsible for any loss, theft or damage to property, including but not limited to equipment, facilities, and buildings belonging to the City of Barstow other persons caused directly or indirectly by Participant in connection with Event.*

*I give permission to the City of Barstow, its officers, officials, employees, agents and volunteers to photograph or videotape Participant in the Event for use in future city publications and/or in other promotional advertisement. I understand that I will not receive any compensation for such use.*
