RECREATION LEADER & LIFEGUARD TRAINEE Part-Time / At-Will

THE POSITION

The City of Barstow is looking for positive and energetic individuals interested in providing limited seasonal support functions and assistance in organizing a variety of recreation programs including but not limited to: cultural activities, youth sports, swimming programs, Sportspark & park-centered recreation programs, and **other duties as assigned**. Patiently work with citizens, respond to citizen's questions and engage citizens in activities. Individuals may be assigned to various work shifts, including nights, weekends and holidays.

In addition, for the position of as a Lifeguard Trainee, individuals who are a minimum of 17 years of age and who are selected to support and assist with the City's various swimming program will be required to successfully complete the following training:

- Cardio-Pulmonary Resuscitation/Automated External Defibrillator (CPR/AED) for the Professional Rescuer
- Lifeguarding/First-Aid Certification

QUALIFICATIONS

Applicants must be 16 years of age or older at the time of application and be enrolled in high school and have the ability to obtain a current, valid work permit or possess a High School Diploma, or equivalent. Six (6) months of paid work and cash handling experience is preferred.

Applicants must also possess a valid, unrestricted, California Class C Driver's License, provisional license or driver's permit. If applicant is in possession of a provisional license or driver's permit, a copy of a valid, unrestricted driver's license must be provided immediately upon receipt.

NOTE: In compliance with the California Vehicle Code, Section 12814.6, minors from the age of 16 to 18 years of age possessing a provisional driver's license shall be subject to all of the following restrictions:

1. During the first 12 months after issuance of a provisional license, the licensee may not do any of the following unless accompanied and supervised by a licensed driver who is the licensee's parent or guardian, a licensed driver who is 25 years of age or older, or a licensed or certified driving instructor
 - a) Drive between the hours of 11:00 p.m. and 5:00 a.m.
 - b) Transport passengers who are under 20 years of age.

SELECTION PROCEDURE

All application materials received will be reviewed and those candidates whose training and experience best meet the needs of the City will be invited to participate in an oral interview

COMPENSATION AND BENEFITS

The salary range for the **Recreation Leader / Lifeguard Trainee** is **\$12.00 to \$15.00 per hour**. No benefits are provided for this part-time / at will position. Upon receipt of a Lifeguard Certification a premium will be paid at the employee's current step when performing lifeguard duties.
