**What You'll Be Doing:** Under direct supervision, performs routine laboratory tests and skilled tasks in the operation and servicing of wastewater machinery and equipment.

### **EXAMPLES OF ESSENTIAL DUTIES:**

- Inspect, maintain, repair, install and modify wastewater equipment, electrical and electronic systems and facilities; reports need for major or specialized repairs.
- Operate wastewater equipment and machinery.
- Reads gauges, meters, charts and graphs and operates pumps, valves, electric motors and related equipment.
- Monitors systems; control valves for emergency and scheduled shut down; troubleshoots, diagnoses, and reports problems to superiors.
- Collect samples for quality control and determine amount of chemicals needed and adds for treatment process.
- Clean tanks and facilities; maintain buildings and grounds.
- Fulfill work orders and work assignments.
- Perform related duties as assigned.

### **QUALIFICATIONS:**

Any combination of education and experience that would provide the required knowledge, abilities and skills is qualifying. A typical way to obtain the qualifications would be:

- High school diploma or equivalent, 6 educational point (As listed in Title 23, Chapter 26, Division 3, Section 3685 and 3686 of the Water Code) and one (1) year experience in equipment and facilities maintenance, preferably in the wastewater industry.

## **LICENSE OR CERTIFICATE**

- Possession of a valid Class C California Driver's License. Ability to obtain a Class A license within 12 months of appointment
- Must obtain a California Wastewater Treatment Operator I Certificate or higher within 4 testing cycles of receiving your Operator in Training Certificate or 24 months of appointment, whichever comes first.
- Must obtain a California Wastewater Treatment Operator II Certificate or higher within 4 testing cycles of receiving your California Wastewater Treatment Operator I Certificate.

## **COMPENSATION AND BENEFITS**
